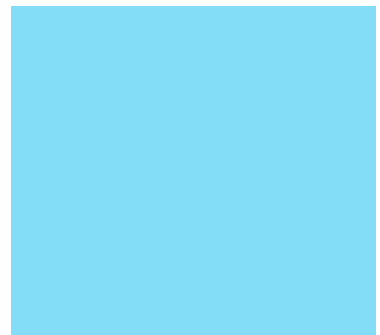

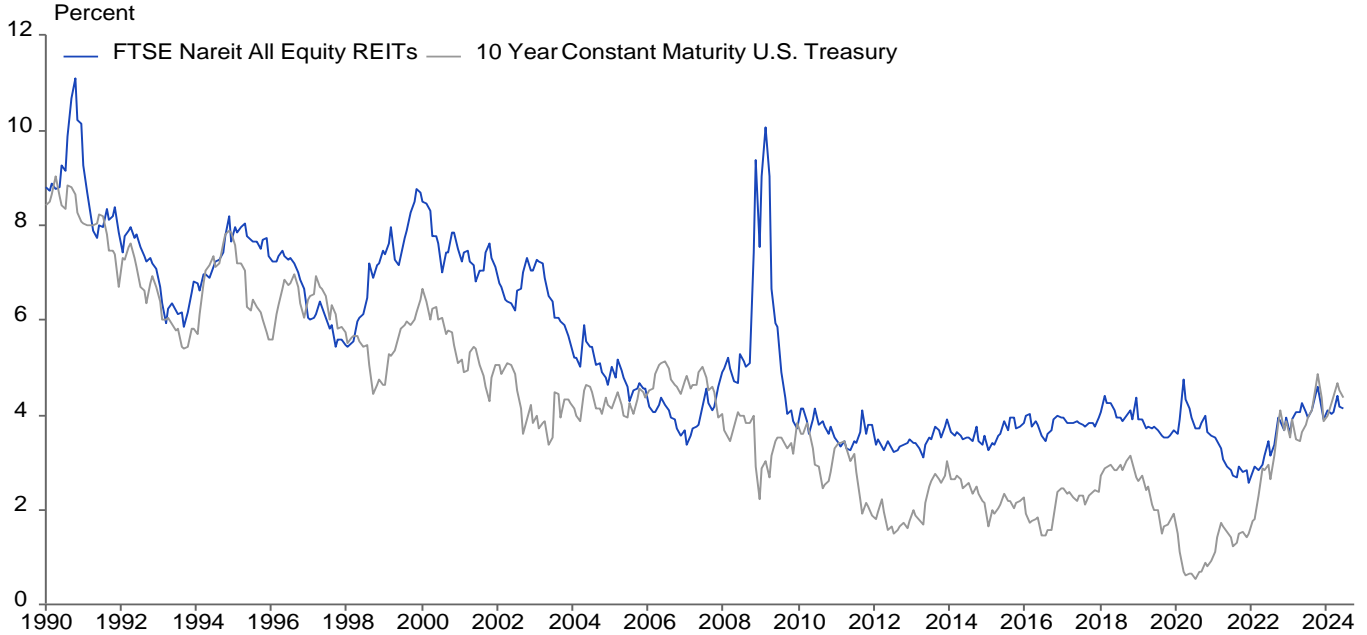

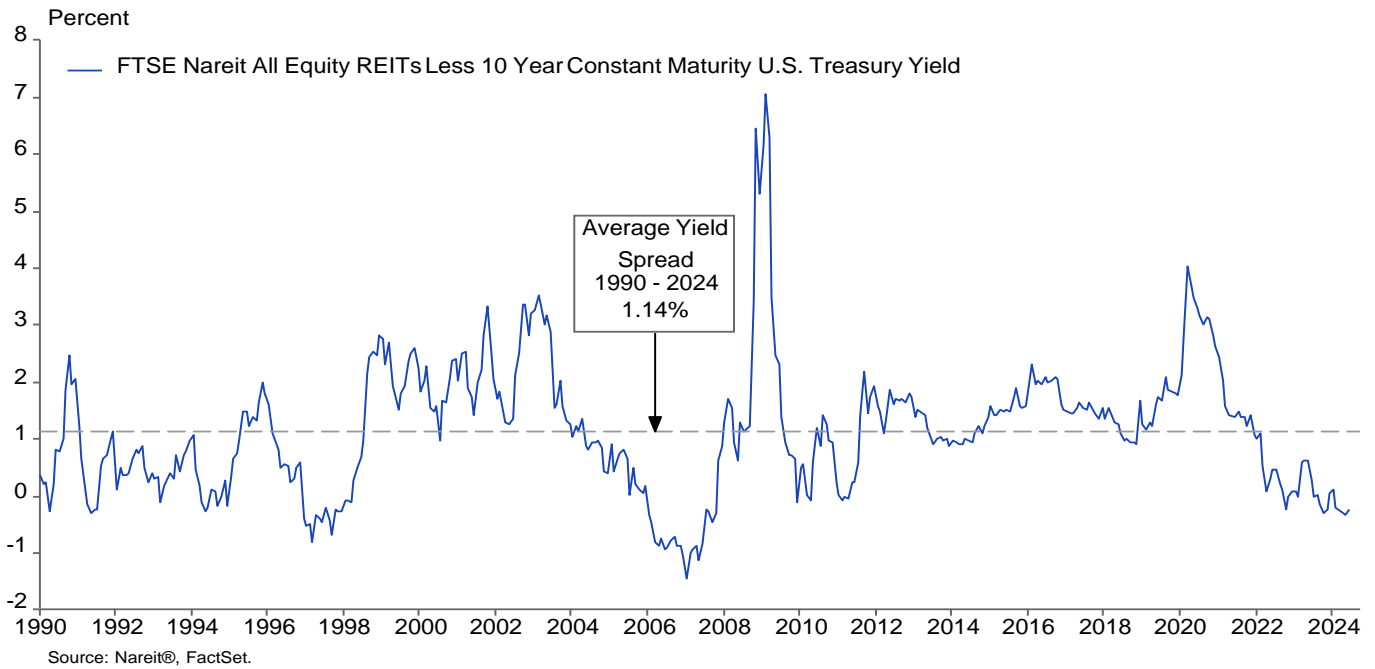

Monthly Total Return Index Comparison

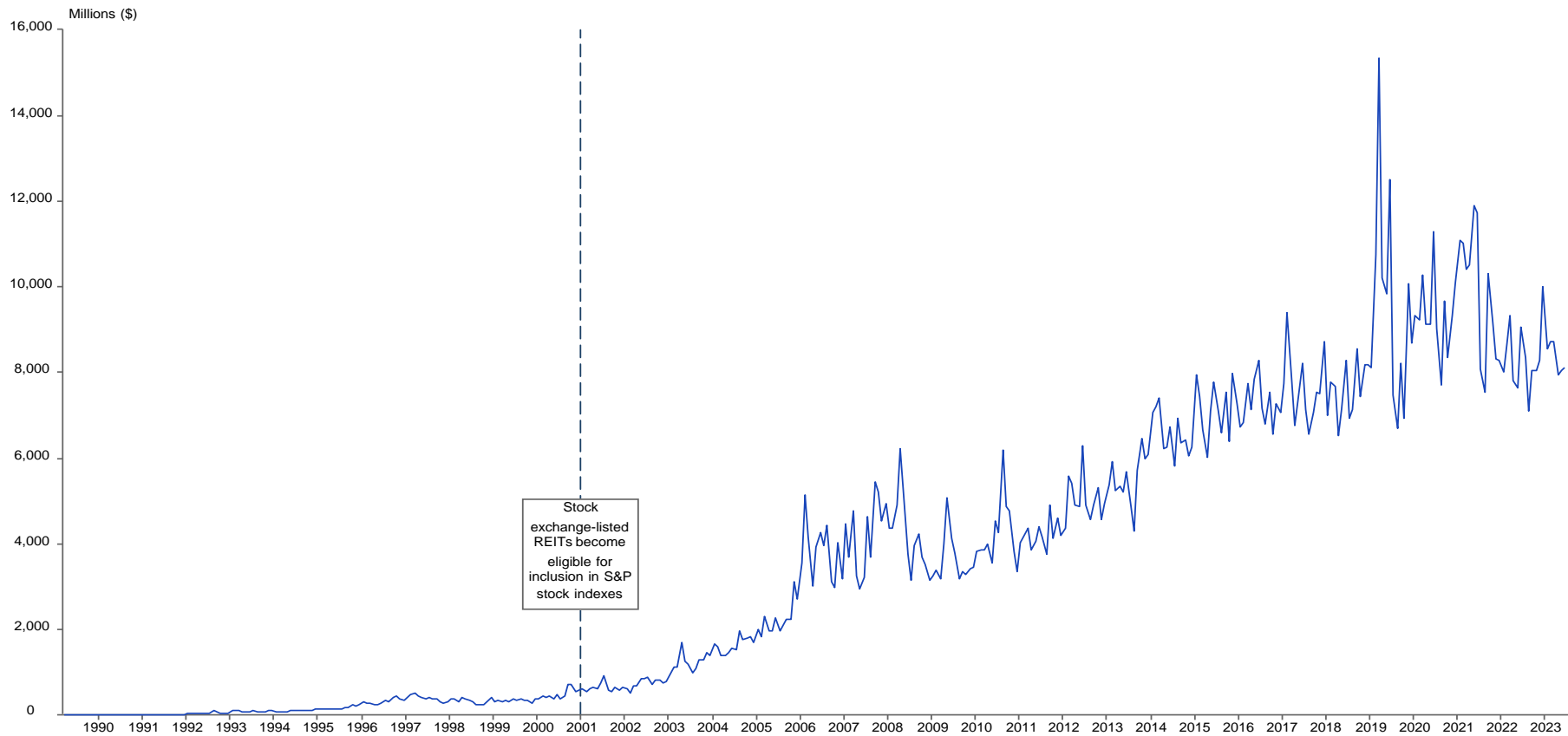

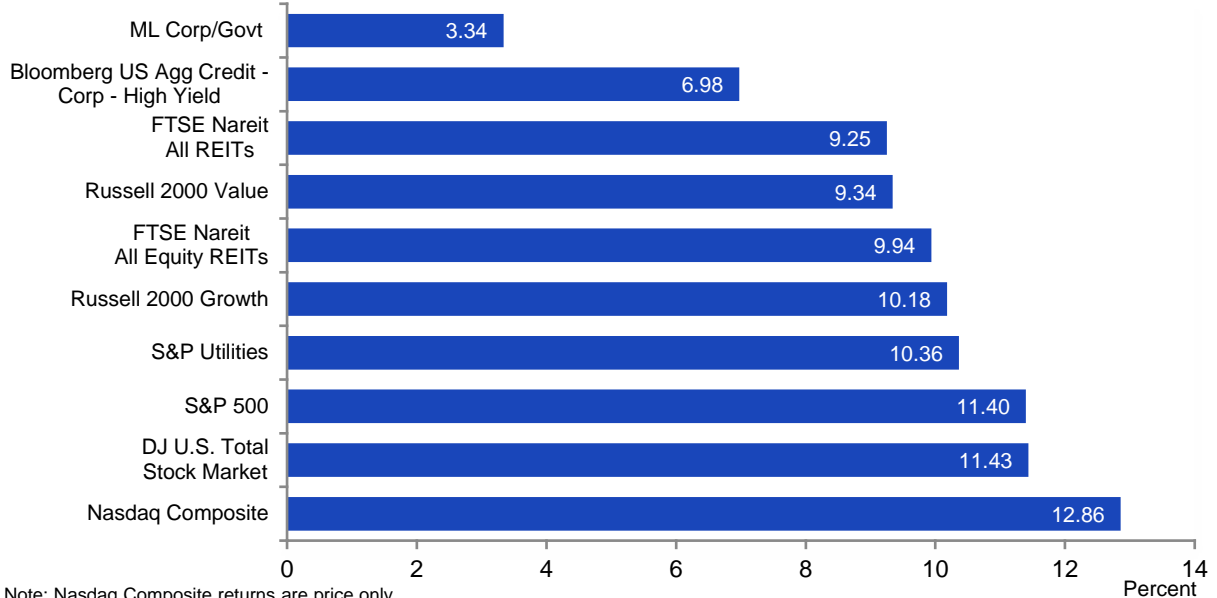

20-Year Average Annual Total Return

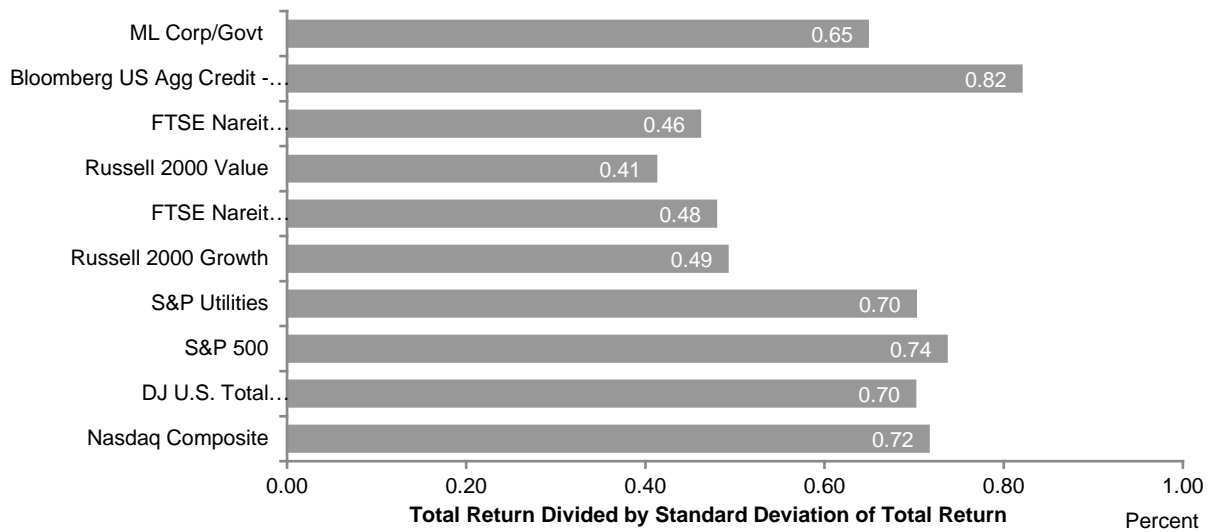

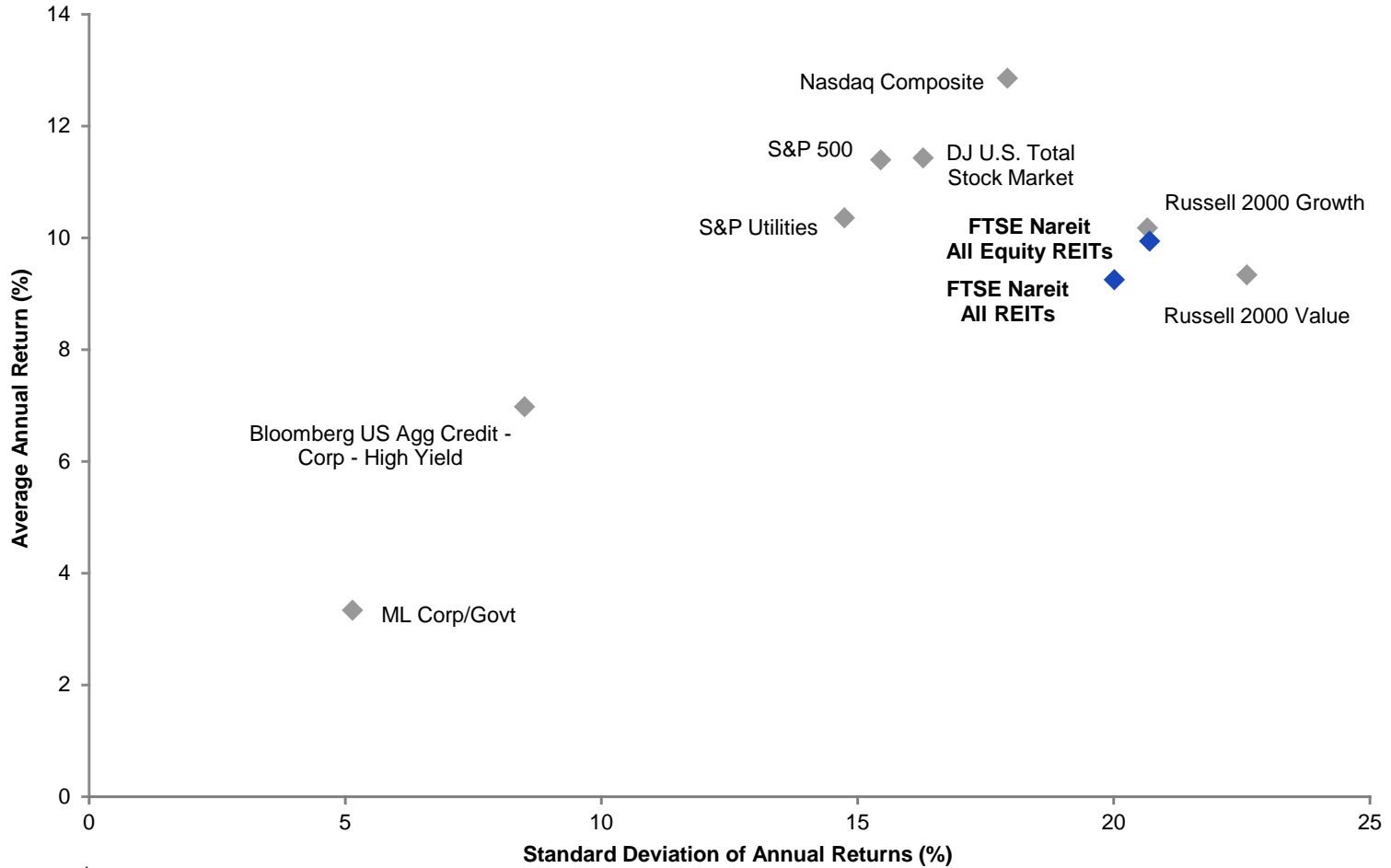
Adjusted 20-Year Average Annual Total Return

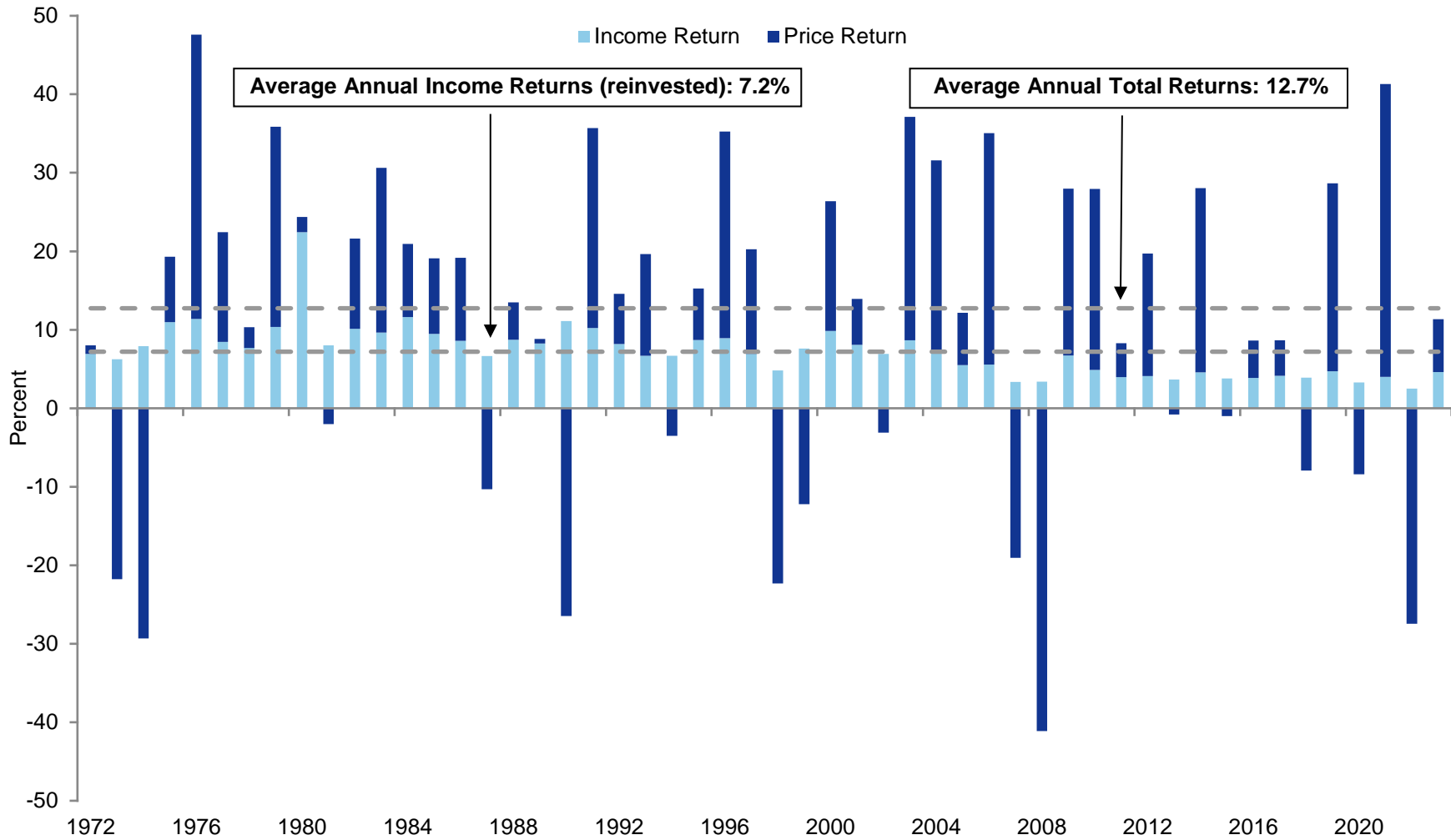
**20-Year Average Annual Total Return v.

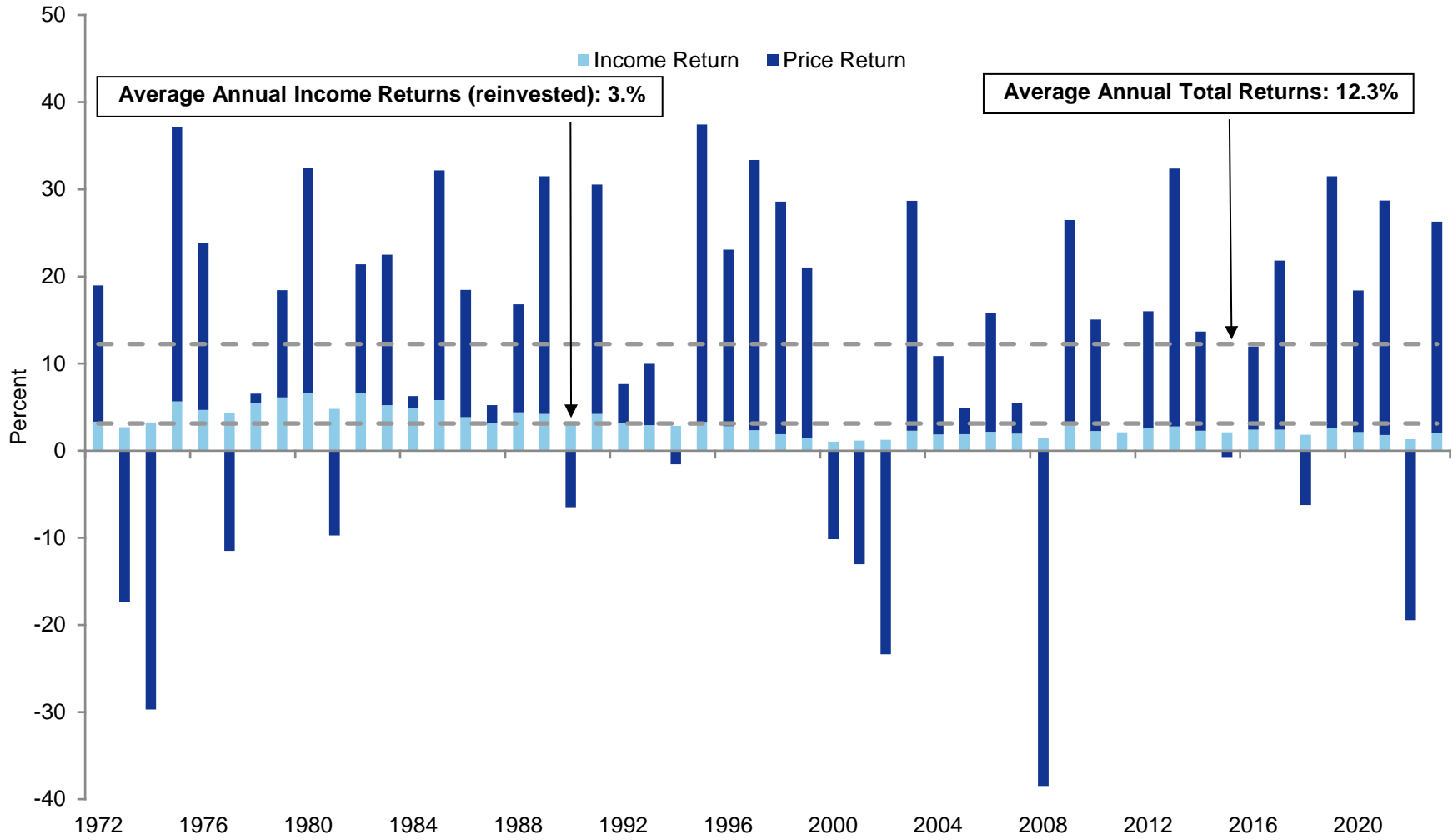

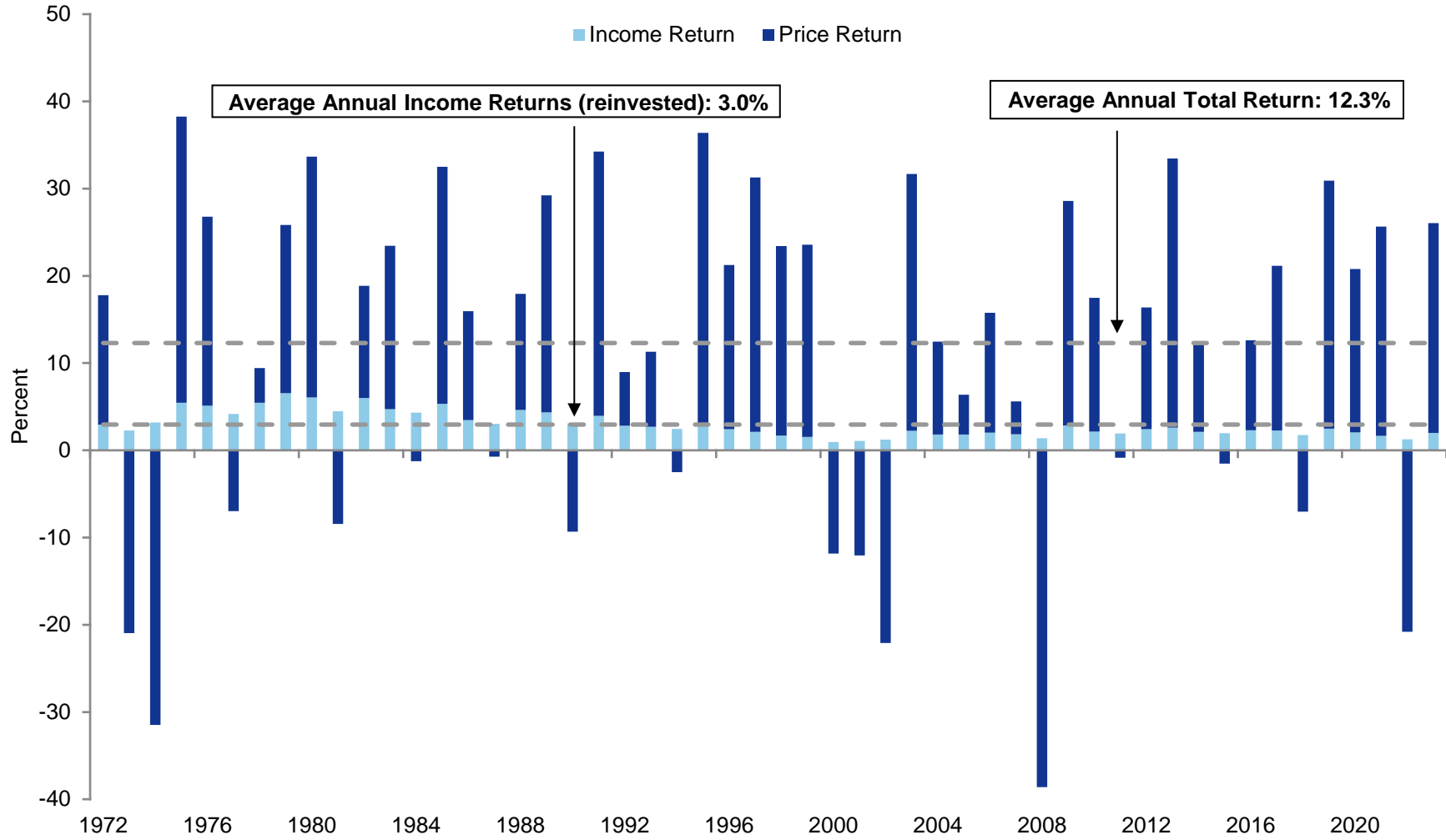
S&P 500

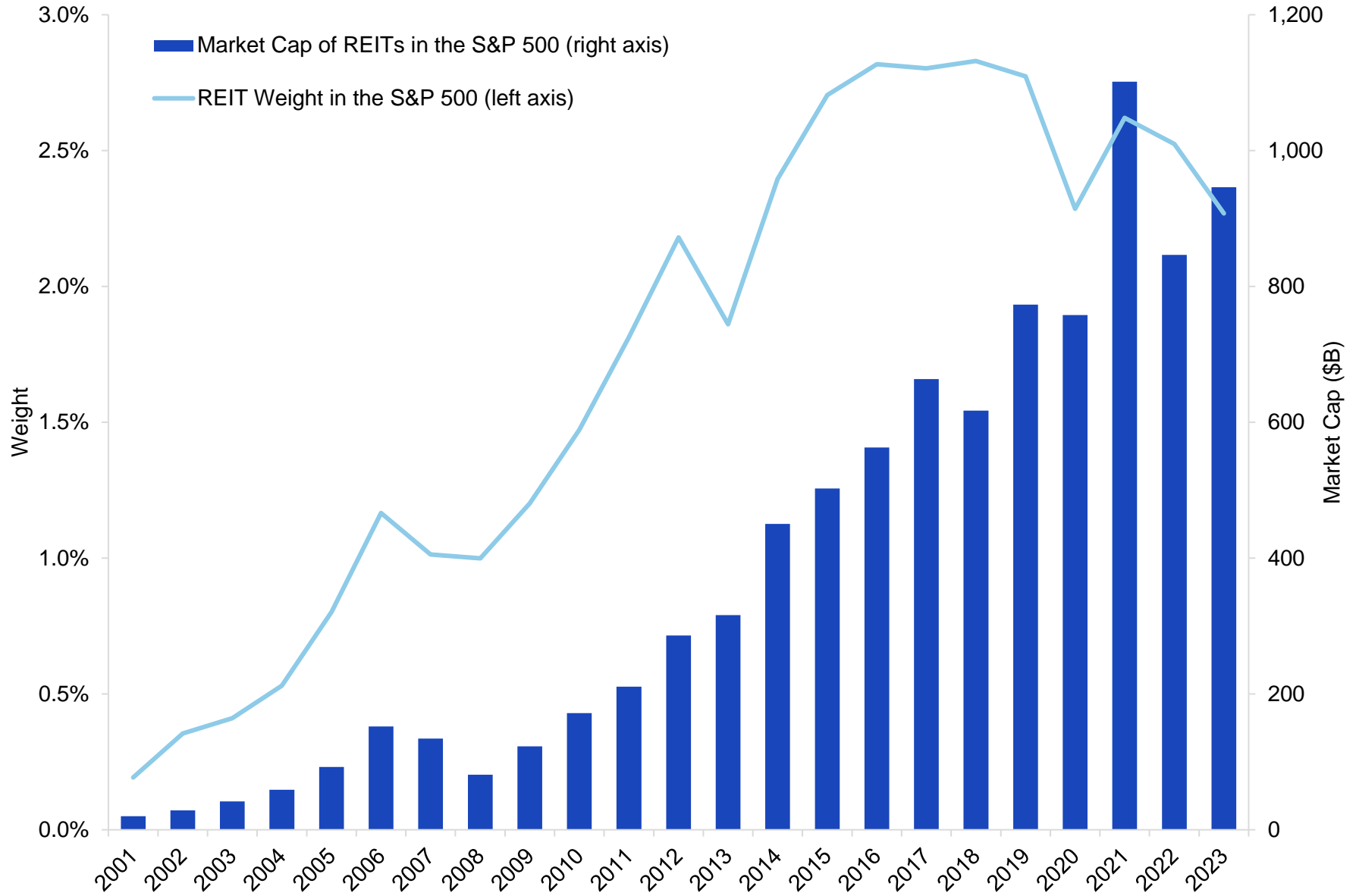

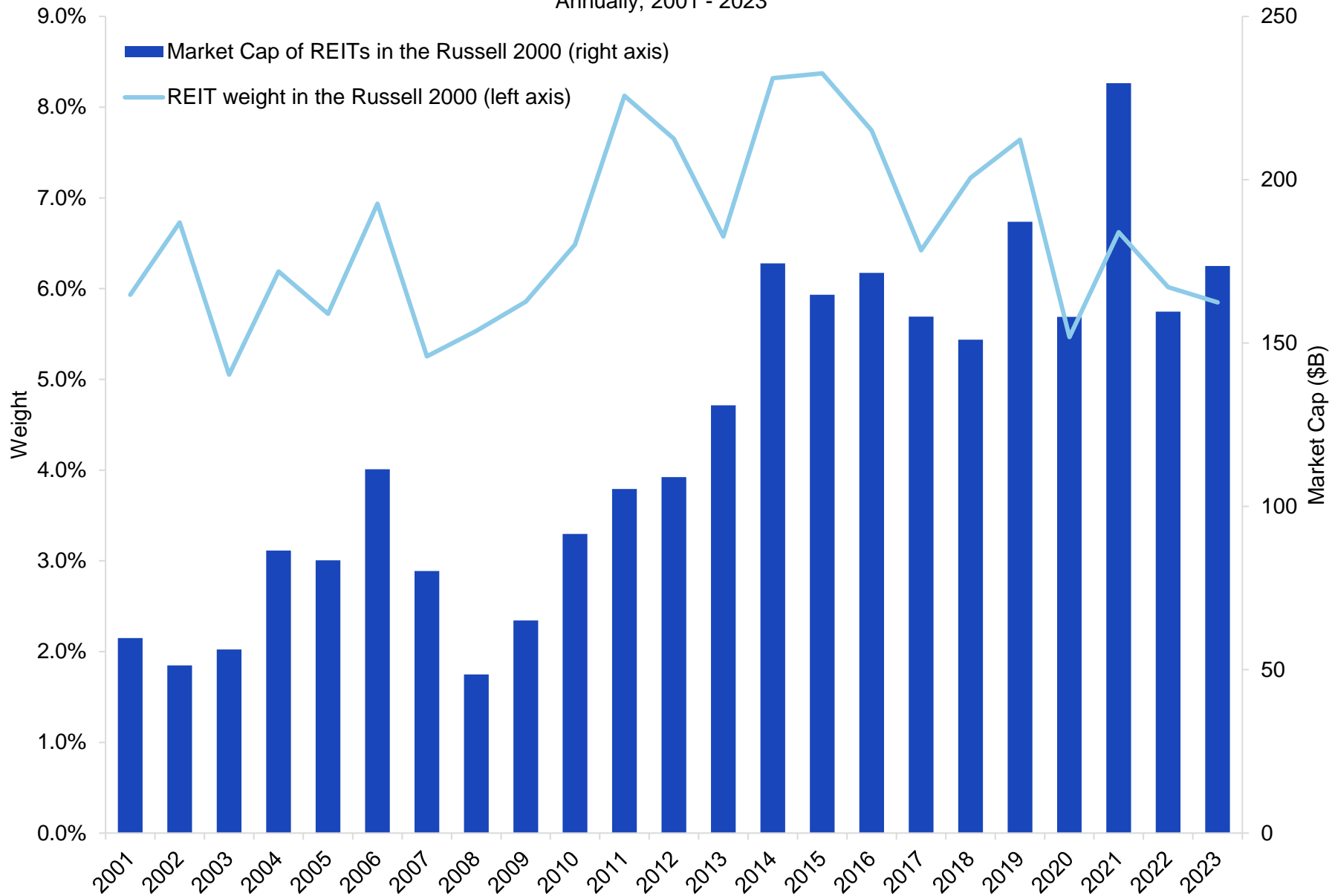
REITs in the S&P 500

Annually, 2001 - 2023

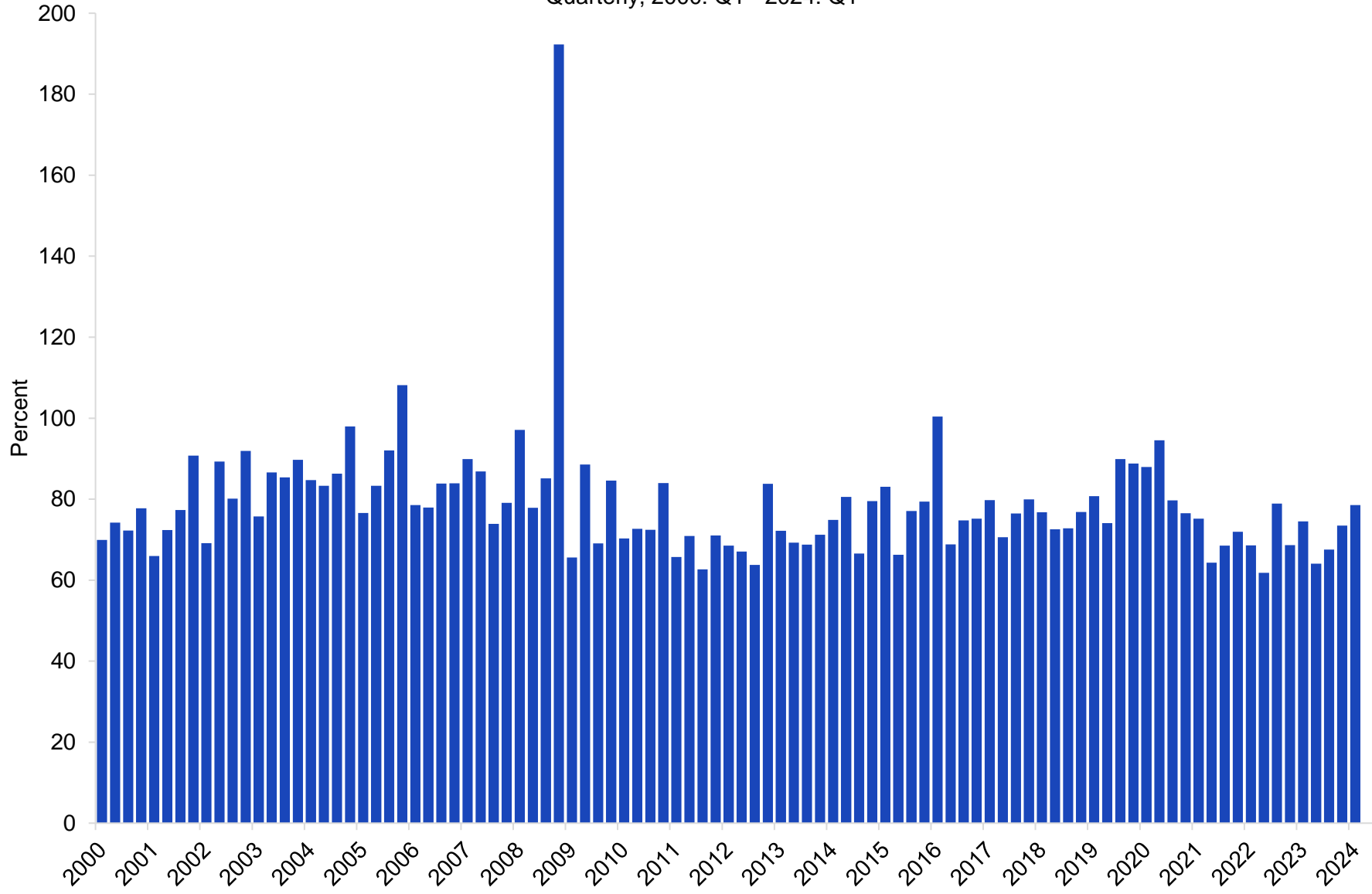

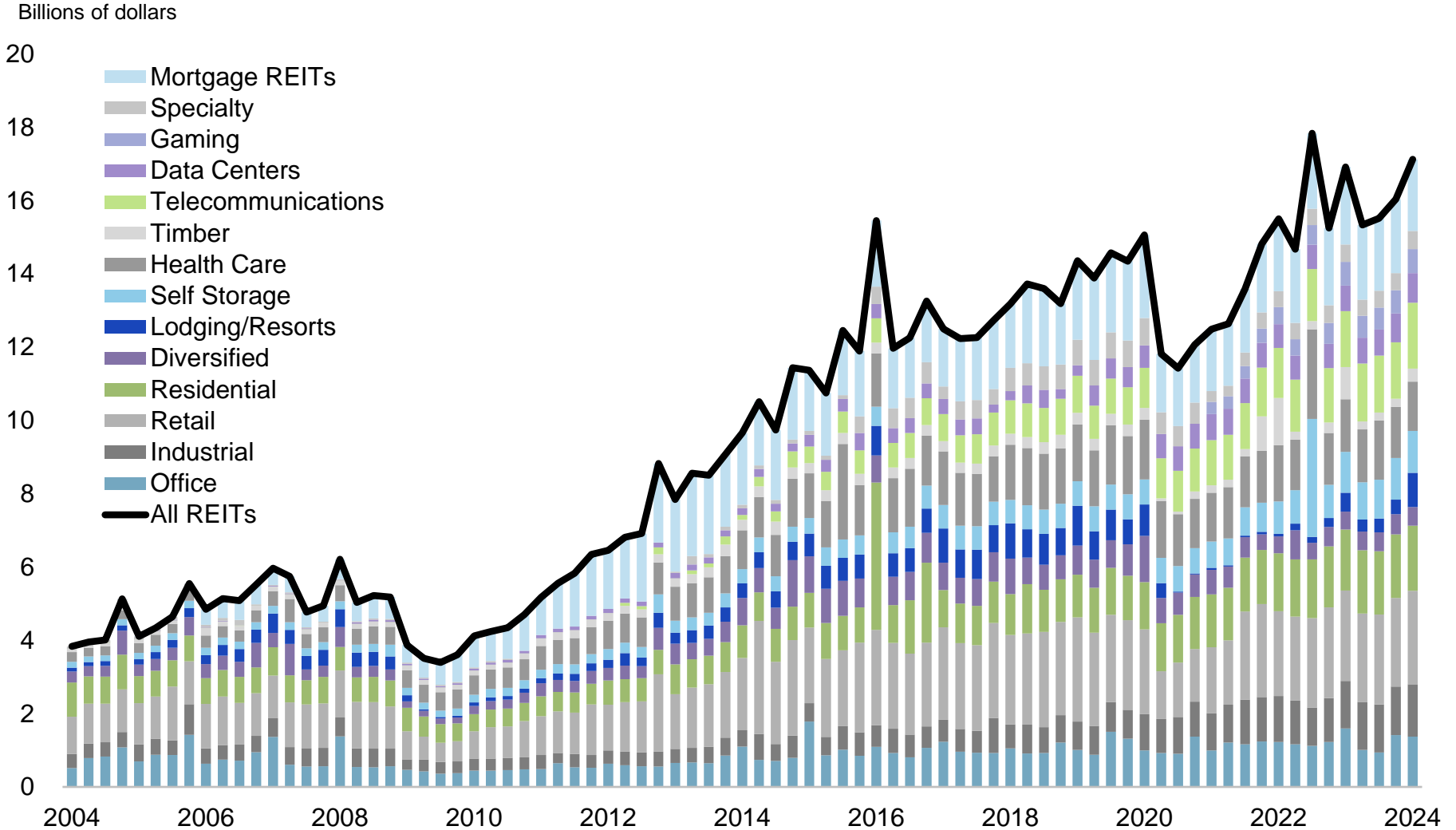
FTSE Nareit All Equity REITs:

All listed U.S. equity and mREITs



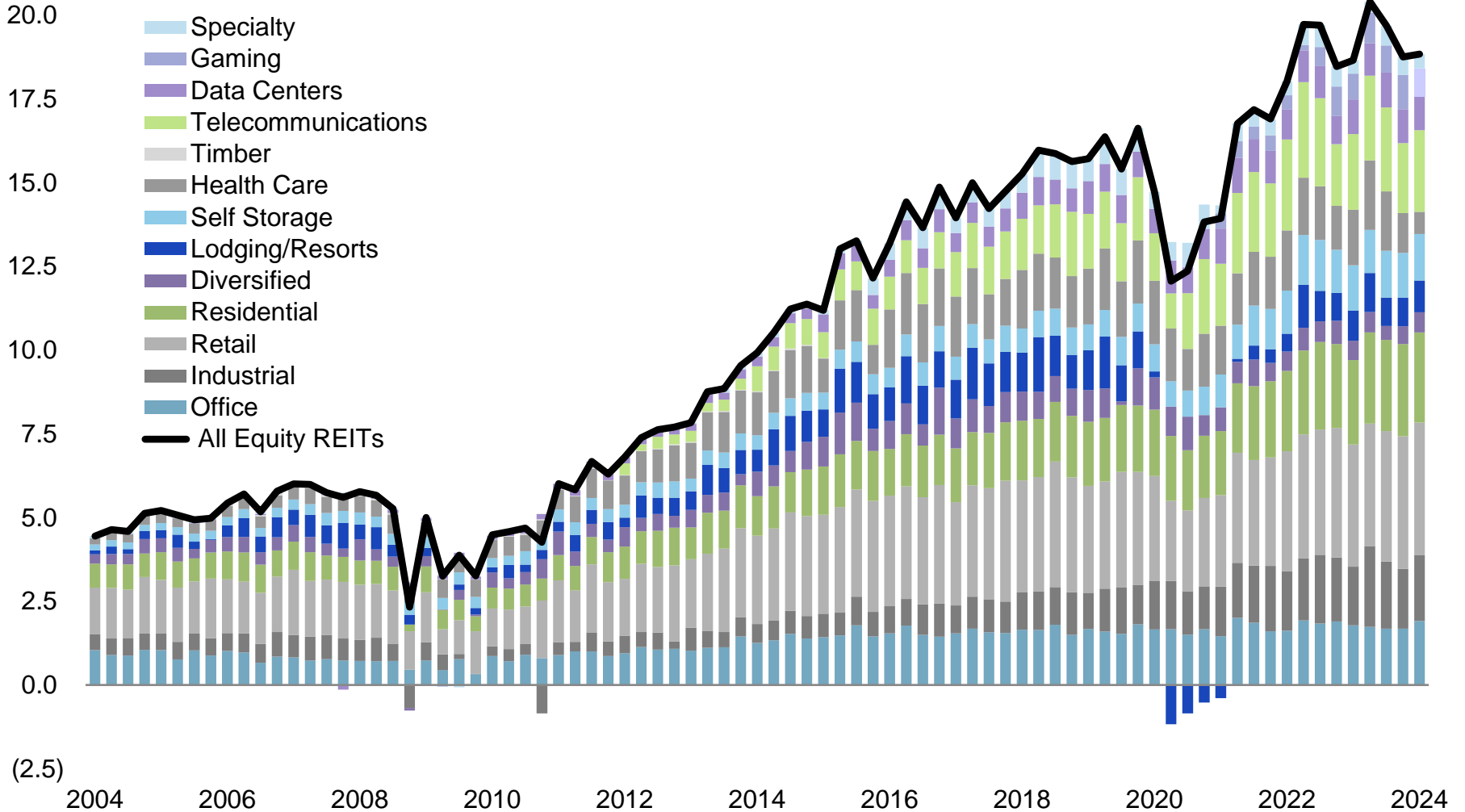
